ORDINANCE NO. 2008-09

**AN ORDINANCE AMENDING AND
SUPPLEMENTING CHAPTER 205 OF THE CODE
OF THE TOWNSHIP OF SOUTH HACKENSACK
ENTITLED "VEHICLES AND TRAFFIC"**

Be it Enacted and Ordained, by the Township Committee of the Township of South Hackensack that Chapter 205 of the Code of the Township of South Hackensack is hereby amended and supplemented as follows:

Section I. Article V "Handicapped Parking", Section 205 -33B Handicapped Parking is hereby amended to include:

Street	Number of Spaces	Location
35 Dinallo Street	one (1)	Along the southern curb line of Dinallo Street beginning at utility pole #P60251TSH and proceeding west along the curb line for 22 feet and extending north 8 feet into the roadway from the west side curb line.

Section II. Repealer/Severability: If any ordinance or part of any ordinance is inconsistent with this ordinance the same is hereby repealed to the extent of any

inconsistency. If any portion of this ordinance is held unconstitutional or invalid the remaining portions shall remain in full force and effect.

Section III. Effective Date: This ordinance shall take effect upon passage and publication as required by law.
