Call of Meeting to Order

Mayor Romano called the Regular Meeting to order at 7:30 p.m. She advised that pursuant to the Open Public Meetings Act adequate notice of the meetings had been provided to *The Record, The Herald and News* and by posting a notice on the bulletin board in the clerk's office where notices are customarily posted. Everyone saluted the flag. The municipal clerk called the roll.

Correspondence & Reports

Report on Senior Housing at Grove Street –

Bart Mongelli, Esq., Shari DePalma and Lillian Ciuffo appeared on behalf of Grove Street Housing, LLP to report on the status of their funding for the Grove Street Senior Housing Project.

PNC Bank is requesting further lease amendments and once approved closing can take place. Mr. Carbone indicated that he would advise against approving the requested lease amendments that include the unilateral removal of the general partner and rental increases without prior Township Committee approval. Mr. Mongelli advised that he would go back to PNC. Regarding the rather large hole that was dug and has not been filled, DePalma reported that although Madeline Corp paid for the environmental clean up, further work can not begin until financing is in place.

Report on COAH's 3rd round submission – Kauker & Kauker

Michael Kauker reported that there has been good progress on the preparation of the 3rd round growth share obligation submission to COAH that is due December 31, 2008. The Planning Board will be required to arrange for and conduct a public hearing. The main task is to identify and calculate the township's growth share obligation. Once we have filed and are approved, our plan will be valid 2004 through 2018. COAH has our current obligation of low/mod housing units at 40. His intention is to reduce that obligation to 6-

16. He must identify demolitions, visit sites and interview individuals involved to determine the vacancy time, etc. He will focus on the fair share number, the actual growth share is not real until growth occurs & CO's are issued. He suggested that the Township Committee meet immediately after the Planning Board to adopt the plan prior to the deadline.
