Scott, Collector of Taxes of the Township of South Hackensack, in the County of Bergen, State of New Jersey on Thursday, **December 19, 2024 at 11:00 a.m**. in the Municipal Complex, 227 Phillips Avenue, South Hackensack, N.J. or at such later time and place to which said sale may then be adjourned, will expose for lien sale and sell the several parcels of land on which taxes and/or other municipal charges remain unpaid for the year 2024 and prior subject to N.J.S.A. 54:5 et seq. Said properties will be sold subject to redemption at the lowest rate of interest, but in no case shall exceed 18% per Annum. Payment for liens purchased shall be made via cash, money order, or certified check prior to the conclusion of the sale. A separate check is required for premiums.

Industrial Properties may be subject to the Spill Compensation and Control Act (N.J.S.A. 58:10-23.11 et seq.), the Water Pollution Control Act (N.J.S.A. 58:10A-1 et seq.) and the Industrial Site Recovery Act (N.J.S.A. 13:1K-6 et seq.). In addition, the municipality is precluded from issuing a tax sale certificate to any prospective purchaser who is or may be in any way connected to the prior owner of the site. In the event the owner is on active duty with the military, the collector should be notified immediately.
