Resolution No. 2019-183 AUTHORIZING PAYMENT TO WEEPING PINES LANDSCAPING, INC. FOR LANDSCAPE SERVICES FOR VETERANS PARK

WHEREAS, the Township undertook extensive renovation to Veteran's Park; and

WHEREAS, a review of said renovations by the Township's municipal engineers, Neglia Engineering indicated that numerous plants were dead, diseased or dying and in need of replacement; and

WHEREAS, Neglia and the Township made numerous attempts over many months to have the original landscape contractor address said issues without success; and

WHEREAS, based upon the lack of response from the original landscape contractor and recommendation of Neglia Engineering the Township did retain the services of Weeping Pines Landscaping, Inc who removed the affected plantings, purchased replacement plantings and installed the same all in accordance with the specifications and directions of Neglia Engineering.

NOW THEREFORE, be it resolved that the aforementioned services, as previously authorized by the Township Committee, are ratified and payment of invoices dated November 4, 2019 in the

amount of \$4,300.00 and November 19, 2019 in the amount of \$24,342.50 be and the same is hereby authorized upon presentation of required vouchers and funds permitting.
